

ORDINANCE NO. 357

AN ORDINANCE OF THE TOWNSHIP OF ANTRIM,  
FRANKLIN COUNTY, PENNSYLVANIA  
PROHIBITING PARKING AND ESTABLISHING TOW AWAY ZONES  
IN THE ANTRIM TOWNSHIP COMMUNITY PARK

**WHEREAS**, Section 1527 of the Second Class Township Code, as amended, (53 P.S. 66527) authorizes the Board of Supervisors of Second Class Townships to adopt ordinances to secure the safety of persons or property within the Townships; and

**WHEREAS**, Section 2328 of the Second Class Township Code, as amended, (53 P.S. 67328) authorizes the Board of supervisors of Second Class Townships to adopt ordinances regulating parking and further authorizes the imposition of penalties for violations of the parking regulations; and

**WHEREAS**, the Pennsylvania Vehicle Code authorizes local authorities on public property of the local authority within their physical boundaries to establish procedures governing the removal and impoundment of any vehicle parked on public property in violation of any local ordinance (75 Pa. C.S.A. §6109); and

**WHEREAS**, Section 3353 of the Pennsylvania Vehicle Code (75 Pa.C.S.A. §3353) authorizes Townships to remove vehicles that are not parked legally; and

**WHEREAS**, the Vehicle Code provides that local authorities may exercise the powers granted in the code only by duly enacted ordinances of their governing bodies (75 Pa. C.S.A §6102-b).

**NOW THEREFORE, BE IT ENACTED AND ORDAINED**, by the Board of Supervisors of the Township of Antrim, Franklin County, Pennsylvania, pursuant to the authority as described above that the Code of the Township of Antrim shall be amended in the following manner:

**Section 1:** Chapter 139-29 entitled "Parking prohibited at all times in certain locations." shall be amended by the addition of the following:

"Parking in any areas at the Antrim Township Community Park other than designated parking spaces. Designated parking spaces are paved and professionally striped white to create a parking space."

**Section 2:** Chapter 139-38 entitled "Tow-Away Zones Designated" shall be amended by the addition of the following:

"Any area at the Antrim Township Community Park that is not a designated parking space. Designated parking spaces are paved and professionally striped white to create a parking space."

**Section 3:** The penalties for violating this ordinance shall be as set forth in the Pennsylvania Vehicle Code, as amended.


**Section 4:** The provisions of this ordinance shall be severable, and if any of its provisions shall be held to be unconstitutional, illegal, or invalid, such unconstitutionality, illegality or invalidity shall not affect the remaining provisions of this ordinance.

**Section 5:** All other ordinances or parts of ordinances inconsistent herewith are hereby repealed.

**Section 6:** This ordinance shall take effect in accordance with the law.


