

**ORDINANCE NO. 2023-15**

**AN ORDINANCE AMENDING THE CODE OF THE BOROUGH OF BERLIN  
CHAPTER 315, ARTICLE XVI, §315-32 SCHEDULE I: NO PARKING ON FRANKLIN  
AVENUE, BOTH SIDES, FROM 140 S. FRANKLIN AVENUE TO CLEMENTON ROAD,  
WEEKDAYS 7:00 A.M. THROUGH 3:00 P.M., WHILE THE BERLIN COMMUNITY SCHOOL  
IS IN SESSION, IN THE BOROUGH OF BERLIN, COUNTY OF CAMDEN AND  
STATE OF NEW JERSEY**

**WHEREAS**, the Borough of Berlin (“Borough”) is a municipal entity organized and existing under the laws of the State of New Jersey and located in Camden County; and

**WHEREAS**, the Borough’s Mayor and Council believe it to be in the best interest and welfare of the public to modify Chapter 315, Article XVI, Schedule I, of the Code of the Borough of Berlin; and

**NOW, THEREFORE, BE IT ORDAINED** by the Mayor and Borough Council of the Borough of Berlin, County of Camden, State of New Jersey, as follows:

**Section 1:** Chapter 315, Article XVI of the Code of the Borough of Berlin, entitled §315-32 Schedule I: No Parking - is hereby amended to add:

In accordance with the provisions of § **315-3**, no person park a vehicle at any time upon the following described streets or parts of streets:



**Section 2:** All other Ordinances or parts of Ordinances inconsistent with the provisions of this Ordinance are hereby repealed to the extent of such inconsistency.

**Section 3:** If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such subdivision, clause or provision and the remainder of this Ordinance shall be deemed valid and effective.

**Section 4:** This Ordinance shall take effect immediately upon final passage and publication as required by law.


