ORDINANCE CONFIRMING AND AUTHORIZING THE SALE OF LAND IN ACCORDANCE WITH THE REQUIREMENTS OF THE LOCAL LANDS AND BUILDINGS LAW FOR BLOCK 33, LOT 21.18 (934 ALCYON DRIVE) IN THE BOROUGH OF BELLMAWR, COUNTY OF CAMDEN AND STATE OF NEW JERSEY
