ORDINANCE NO. 2023-8

AN ORDINANCE OF THE TOWNSHIP OF BRISTOL, BUCKS COUNTY, PENNSYLVANIA AMENDING SECTION 191-24 OF CHAPTER 191, VEHICLES AND TRAFFIC, OF THE BRISTOL TOWNSHIP CODE OF ORDINANCES AMENDING SECTION 191-43 OF CHAPTER 191, SCHEDULE XX (§191-84) TO AUTHORIZE DISTRICTS DESIGNATED FOR PERMIT PARKING

WHEREAS, the First Class Township Code permits the Council for the Township of Bristol to establish vehicular regulations; and

WHEREAS, Council has reviewed the various traffic situations and have been advised by its Township Professionals and the Township of Bristol Police Department and Administration that the restrictions set forth within this Ordinance are in the best interest of the public health, safety and welfare of the Bristol Township residents.

NOW, THEREFORE, BE IT ENACTED AND ORDAINED BY THE COUNCIL OF THE TOWNSHIP OF BRISTOL:

Section 1. Chapter 191-43, Schedule XX (§ 191-84) of the Bristol Township Code is hereby amended to include the following designated districts for permit parking:

Name of Street	Side	Hours/Days	Location
Bloomsdale Road	Both	At all times	From 2200-2304
Fleetwing Drive	Both	At all times	All
Airacobra Street	Both	At all times	All
Liberator Street	Both	At all times	All
Mustang Street	Both	At all times	All

<u>Section 2.</u> The appropriate Township Officials and employees are hereby authorized and directed to erect appropriate signs at the above-mentioned location.

<u>Section 3.</u> Whenever the requirements of this Ordinance are in conflict with other requirements of the Ordinances of the Township of Bristol, the most restrictive, or those imposing the higher standards, shall govern.

<u>Section 4</u>. The provisions of this Ordinance are severable. If any section, clause, sentence, part or provision hereof shall be held illegal, invalid or unconstitutional by any court of competent jurisdiction, such decision of the court shall not affect or impair any of the remaining sections, clauses, sentences, parts or provisions of this Ordinance. It is hereby declared to be the intent of the Council of Bristol Township that this Ordinance would have been adopted if such illegal,

invalid or unconstitutional section, clause, sentence, part or provision had not been included herein.

Section 5. This Ordinance shall become effective immediately.
