## BE IT ORDAINED AND ENACTED ON MAY 10, 2023 BY THE TOWN OF CICERO, COUNTY OF ONONDAGA, STATE OF NEW YORK, AS FOLLOWS:

## LOCAL LAW FILING - Town of Cicero

Local Law No. 7 of the year 2023

A local law adopting a resolution enacting a Temporary Moratorium on the consideration, approval, and development of recreational vehicle parks within the Town of Cicero for a period of one (1) year from the effective date of the Local Law, or sooner if new legislation is enacted either canceling said moratorium or amending the Policy and Code of the Town of Cicero with regard to recreational vehicle parks. The purpose of this Local Law is to stay any and all actions, including but not limited to pending applications, regarding recreational vehicle parks until the presentation and passage of amended Town Policy and Code provisions addressing the same.) as proposed by adopting Local Law 7 of 2023 as drafted and submitted. This Local Law shall become effective upon filing with the NY Secretary of State. To be known as Local Law #7 of 2023.

Be it enacted by the Town Board of the Town of Cicero as follows:

I. Local Law 7 of 2023 – Approves adopting a resolution for a temporary moratorium on the development of recreational vehicle parks is added hereby:

## DECISION

Motion was made by Councilor Karp.

Move for the adoption of a resolution that the Town Board approves/denies the proposed Town of Cicero Local Law Number 7 of the Year 2023, enacting a Temporary Moratorium on the consideration, approval, and development of recreational vehicle parks within the Town of Cicero for a period of one (1) year from the effective date of the Local Law, or sooner if new legislation is enacted either canceling said moratorium or amending the Policy and Code of the Town of Cicero with regard to recreational vehicle parks. The purpose of this Local Law is to stay any and all actions, including but not limited to pending applications, regarding recreational vehicle parks until the presentation and passage of amended Town Policy and Code provisions addressing the same. To be known as Local Law #7 of 2023.

A LOCAL LAW titled Town of Cicero Local Law Number 7 of 2023 and known as the "Temporary Moratorium for Recreational Vehicle Parks for the Town of Cicero."

IT IS HEREBY ORDAINED AND ENACTED by the Town Board of the Town of Cicero, Onondaga County, New York, as follows: That Town of Cicero Local Law Number 7 titled "Temporary Moratorium for Recreational Vehicle Parks" is hereby adopted to enact a one (1) year moratorium prohibiting the application or approval of any new recreational vehicle parks within the Town of Cicero.

The purpose of said Local Law is to provide for a temporary moratorium against the consideration of any and all applications for site plans for recreational vehicle parks to allow time for the Town Board to further investigate and study issues related to the development of the Town's policy regarding the preservation and best use of Agricultural (AG) zoning districts, as well as whether additional regulations regarding recreational vehicle parks are necessary for the protection of nearby property owners.

This temporary moratorium may be further extended or terminated by the Town Board. This law does not apply to existing permitted uses but does apply to pending applications.

Said local law reads as follows:

## LOCAL LAW

"Town of Cicero Local Law Number 7 of 2023" is hereby enacted, providing for a Temporary Moratorium as set forth therein, for a period of one-year after the date of filing of this Local Law.

**SECTION 1. PURPOSE.** The purpose of this Local Law is to provide for a Temporary Moratorium for one year after the date of the filing of this Local Law.

**SECTION 2. TIME PERIOD AND PROHIBITION.** As of the effective date of this local law there will be a oneyear moratorium on the consideration of any and all applications for site plans for recreational vehicle parks within the Town of Cicero.

SECTION 3. EFFECTIVE DATE. This Local Law shall take effect immediately upon filing with the Secretary of State.

**SECTION 4. TERMINATION DATE.** This Local Law shall become null and void one year after filing, unless extended or terminated by the Town Board. The proposed moratorium may be extended, or terminated at any earlier period, by the Town Board.
