

ORDINANCE No. 2021-D

AN ORDINANCE OF CONEWAGO TOWNSHIP, ADAMS COUNTY, PENNSYLVANIA, ESTABLISHING A SPEED LIMIT OVER THE ENTIRE LENGTH OF SKYVIEW CIRCLE AND FURTHER ESTABLISHING VARIOUS STOP INTERSECTIONS AND VEHICLE CLASS RESTRICTIONS ON VARIOUS STREETS IN THE TOWNSHIP

WHEREAS, pursuant to the Second-Class Township Code, 53 P.S. § 65101, *et seq.*, the Conewago Township Board of Supervisors (“Board”) may adopt ordinances necessary for the health and welfare of the township and its citizens; and

WHEREAS, traffic regulations have been held to be a valid exercise of police powers in the Commonwealth of Pennsylvania; and

WHEREAS, the Code of Ordinances of Conewago Township (“Conewago Code”) sets forth appropriate traffic regulations in Chapter 145, “Vehicles and Traffic”; and

WHEREAS, pursuant to 75 Pa.C.S. § 3363 of the Pennsylvania Vehicle Code, local authorities may establish a reasonable and safe maximum speed limit not greater than 55 miles per hour—that may be made effective at all times—upon the basis of an engineering and traffic investigation; and

WHEREAS, the Board desires to establish maximum speed limits on certain streets, regulate certain stop sign intersections throughout the Township, and update vehicle class restrictions on certain streets and to add to and delete from said locations from time to time; and

WHEREAS, the Board deems it to be in the best interest and general welfare of the citizens and residents of the Township to set forth the following amendments to Chapter 145, “Vehicles and Traffic.”

BE IT ORDAINED by the Board of Supervisors of Conewago Township, Adams County, Pennsylvania, as follows:

Section 1. Chapter 145, “Vehicles and Traffic,” of the Conewago Code is hereby amended in the following respects (all references to section numbers are sections from the existing chapter):

A. Section 145-8, “Speed limits,” is amended under subparagraph “A” to incorporate the following location in alphabetical order to be included as a speed limit as indicated:

Name of Street	Speed Limit (mph)	Location
Skyview Circle	25	Entire length

B. Section 145-11, “Stop intersections,” is amended under subparagraph “A” to incorporate the following locations in alphabetical order to be included as stop intersections with official stop signs erected as indicated:

Name of Street	Direction of Travel	At Intersection of
Hemlock Drive	North	Oxford Avenue

- C. Section 145-12, "Vehicle class restrictions," is amended under subparagraph "A" to incorporate the following locations in alphabetical order to be included as vehicle class restrictions as indicated:

Name of Street	Location
Skyview Circle	Entire length
Galaxy Drive	Entire length
Solar Court	Entire length

Section 2. Penalty:

Any person who shall violate any provision of this Ordinance shall be subject to such fines and penalties as are established under the Pennsylvania Vehicle Code, 75 Pa.C.S. §§ 101, *et seq.*, as amended.

Section 3. Severability:

In the event any portion of this Ordinance shall be held to be unconstitutional, all remaining portions of this Ordinance shall remain in full force and effect.
