

CUMBERLAND TOWNSHIP, ADAMS COUNTY, PENNSYLVANIA

ORDINANCE NO. 2022-192

AN ORDINANCE AMENDING CHAPTER 15 OF THE TOWNSHIP OF CUMBERLAND CODE OF ORDINANCES, TO AMEND THE MAXIMUM SPEED LIMIT ON PORTIONS OF HERR'S RIDGE ROAD AND OLD MILL ROAD AND TO AMEND THE LIST OF STOP INTERSECTIONS IN CUMBERLAND TOWNSHIP

WHEREAS, the Board of Supervisors of Cumberland Township, Adams County, Pennsylvania (the "Board") may establish a maximum speed limit of twenty-five (25) miles per hour in a residence district in accordance with 75 Pa.C.S.A. § 3362 (a) (1.2) if the highway is not a numbered traffic route and functionally classified by the department as a local highway; and

WHEREAS, the Board may designate any intersection or junction of roadways in the Township as a stop or yield intersection, or junction in accordance with 75 Pa.C.S.A. § 6109; and

WHEREAS, the Board of Supervisors deems it to be in the best interest and the general welfare of the citizens and residents of the Township to amend Chapter 15, of the Township of Cumberland Code of Ordinances relating to maximum speed limits on certain roads and stop intersections in Cumberland Township; and

NOW THEREFORE BE IT ENACTED AND ORDAINED, by the Board of Supervisors of Cumberland Township, Adams County, Pennsylvania, and it is enacted and ordained as follows:

SECTION I: The Township of Cumberland Code of Ordinances, Chapter 15, Part 2, Section 201 entitled, "Maximum Speed Limits Established on Certain Roads", is hereby amended by reducing the maximum speed limit from 35 mph to 25 mph on the following roads:

| <u>Road</u> | <u>Between</u> | <u>Maximum Speed Limit</u> |

| Herr's Ridge Road | US 30 and Old Mill Road | 25 mph |
| Herr's Ridge Road | Old Mill Road and Bream's Hill Road | 25 mph |
| Old Mill Road | Herr's Ridge Road and Country Club Lane | 25 mph |
| Old Mill Road | Country Club Lane to PA 116 | 25 mph |

SECTION II: The Township of Cumberland Code of Ordinances, Chapter 15, Part 2, Section 202 entitled, “Stop Intersections Established”, Subsection 1 is hereby amended to add the following to the existing list of stop intersections:

SECTION III: REPEALER. All provisions of previous Ordinances of Cumberland Township which are contrary to this Ordinance are expressly repealed.

SECTION IV: SAVINGS CLAUSE. In all other respects, the Township of Cumberland Code of Ordinances shall remain as previously enacted and ordained.


SECTION V: SEVERABILITY. The provisions of this Ordinance are severable and if any of its sections, clauses, or sentences shall be held illegal, invalid, or unconstitutional, such provisions shall not affect or impair any of the remaining sections, clauses, or sentences.

SECTION VI: EFFECTIVE DATE. This Ordinance shall take effect in five (5) days.


