## BOROUGH OF FOREST HILLS ORDINANCE NO. 1099

AN ORDINANCE OF THE BOROUGH OF FOREST HILLS, ALLEGHENY COUNTY, PENNSYLVANIA, AUTHORIZING THE AMENDMENT OF THE BOROUGH STREET MAP TO REFLECT THE OFFICIAL RENAMING OF "PERRY AVENUE" TO "BILL TOMASIC WAY."

WHEREAS, Section 1202(12) of the Borough Code, 8 Pa.C.S. § 1202(12), authorizes the Borough of Forest Hills (the "Borough") to regulate streets within the Borough; and

WHEREAS, Section 21-102 of Chapter 21 of the Forest Hills Borough Code of Ordinances, Streets and Sidewalks, as amended, provides for establishment and amendment of the official Borough Street Map, which sets forth the location and name of all roads, streets and alleys in the Borough which have been laid out and opened or dedicated and accepted as public road, streets and alleys therein; and

WHEREAS, the Council of the Borough desires to amend the Borough Street Map to reflect a change in the name of the public street currently identified as "Perry Avenue," being that located adjacent to the Borough Municipal Complex between Greensburg Pike and Barclay Avenue, to be from hereinafter identified as "Bill Tomasic Way," in recognition former Borough Council Member and Borough Council President William "Bill" F. Tomasic, and his many years of service and dedication to the Borough and its residents; and

WHEREAS, the location of "Bill Tomasic Way" has been chosen to honor the support, perseverance, and determination of Former Council President Tomasic without which the new Borough Municipal Complex located adjacent thereto would not have been possible; and

NOW, THEREFORE, the Council of the Borough of Forest Hills hereby ordains and enacts as follows, incorporating the above recitals by reference:

**SECTION 1.** Council hereby authorizes the Borough Engineer and Public Works Manager to amend the Borough Street Map to reflect a change in the name of the public street currently identified as "Perry Avenue," to be hereinafter identified as "Bill Tomasic Way," and to take any additional steps necessary to effectuate the re-naming of the street, including but not limited to procuring and installing new street signs.

**SECTION 2.** Council hereby authorizes the Borough Solicitor to notify any third-party agencies deemed which may benefit from notification of said change, including, but not limited to Allegheny County, the United States Post Office, the Pennsylvania Department of Transportation, or emergency service providers.

**SECTION 3.** All prior ordinances are hereby repealed in whole or in part to the extent inconsistent herewith.

**SECTION 4.** This Ordinance shall take effect in accordance with applicable law.
