**ORDINANCE AMENDING CHAPTER 652
OF THE GREENWICH TOWNSHIP CODE TO REMOVE REPAUNO AVENUE FROM
THE TRUCK ROUTE SYSTEM WITHIN THE TOWNSHIP OF GREENWICH**

WHEREAS, Chapter 652 of the Greenwich Township Code creates a Truck Route System within the Township of Greenwich wherein trucks with a combined gross weight of vehicle plus load in excess of four tons are permitted to travel and operate on certain streets within the Township of Greenwich;

WHEREAS, the entire length of Repauno Avenue within the Township of Greenwich was designated as a part of the truck route; and

WHEREAS, a bypass road was constructed by the Gloucester County Improvement Authority which now provides direct truck access to the Repauno Port from Route 44 (Broad Street) within the Township of Greenwich; and

WHEREAS, the Township Engineer has recommended that the truck route designation be removed from the entire length of Repauno Avenue as the need has been eliminated in light of the construction of the bypass road. See, Engineer's Letter 10/11/23 attached **Schedule A**; and

NOW, THEREFORE, BE IT ORDAINED, by the Township of Greenwich, County of Gloucester, State of New Jersey as follows:

Section 1. §652-1 Establishment shall be amended to remove the following from the list of streets which form the system of truck routes within the Township of Greenwich:

Name of Street	Limits
Repauno Avenue	Entire length

Section 2. All other ordinances in conflict or inconsistent with this Ordinance are hereby repealed to the extent of such conflict or inconsistency.

Section 3. Should any section, paragraph, sentence, clause or phrase of this Ordinance be declared unconstitutional or invalid for any reason, the remaining portions of this Ordinance shall not be affected hereby and shall remain in full force and effect, and to this end the provisions of this Ordinance are hereby declared to be severable.

Section 4. This Ordinance shall take effect within twenty (20) days of final passage and publication and upon approval from the New Jersey Department of Transportation as provided by law.
