Pursuant to the Authority conferred in Section 7-700 of the Village Law of the State of New York, the Board of Trustees of the Village of Green Island hereby adds Section 157-56 and Section 157-57.

Section 1.

Section 157-56 - Uninspected Vehicles

No person shall park, stop or stand any motor vehicle on the public highways of the Village of Green Island, New York unless a Certificate or Certificates of Inspection, as required by the laws of New York State, is or are displayed upon the vehicle or affixed to the registration certificate for the vehicle.

Any violation of this section that occurs while a motor vehicle is parked, stopped or allowed to stand on the public highways of the Village of Green Island shall constitute a parking violation.

Section 157-57 - No Parking, Stopping or Standing

No person shall park, stop or stand any motor vehicle on EITHER SIDE of Cohoes Avenue from Tibbits Avenue north to the Village boundary line.

Section 2. Effective Date.

This local law shall take effect immediately upon filing with the Secretary of State of the State of New York.
