

TOWNSHIP OF HAMPTON

ORDINANCE NO. 841

AN ORDINANCE OF THE TOWNSHIP OF HAMPTON, COUNTY OF ALLEGHENY, COMMONWEALTH OF PENNSYLVANIA, ESTABLISHING VARIOUS FEES IN THE AREAS OF ADMINISTRATION, PLANNING-LAND USE, COMMUNITY SERVICES (PARKS & RECREATION AND PUBLIC WORKS), AS WELL AS PUBLIC SAFETY.

WHEREAS, the Council of the Township of Hampton is empowered to enact, amend or repeal all ordinances, resolutions or motions where such action is consistent with the laws of the United States, the Commonwealth, or the Township Home Rule Charter, and

WHEREAS, in keeping with good practice, Township Council periodically reviews the schedule of fees and makes appropriate revisions thereto,

WHEREAS, the Township Council has determined that a Comprehensive Fee Schedule is necessary and in the best interest of the Township.

NOW, THEREFORE, BE IT ORDAINED, that a Comprehensive Fee Schedule be established as contained herein as identified as Attachment "1" and that this Ordinance shall replace all previous fee schedule ordinances and resolutions.

Furthermore, it is understood that the fees authorized herewith may be amended by the Council of the Township of Hampton from time to time by resolution of Council.



APPENDIX “A”

LAND USE DEPARTMENT

DEFINITIONS & ACRONYMS

- EDU** - “Equivalent Dwelling Unit” – Used for the basis of calculating and billing sewer tap-in fees. One EDU is classified as any group of rooms, house trailer, etc., to be occupied or intended for occupancy as separate living quarters.
- Escrow** – For applications that will require review and/or inspections from outside consultants, an escrow account is required. The Township draws down against the escrow account to reimburse the review/inspection fees from those consultants (engineers/legal counsel). At the end of the project, any positive balance in the escrow account is returned to applicant and any negative balance is billed to the applicant.
- ERU** – “Equivalent Residential Unit” – Used for the basis of calculating and billing property owners for the Township Stormwater Utility Fee. One ERU equals 3,300 square feet of impervious surface area.
- GFA** – “Gross Floor Area” - GFA is based on the TOTAL square footage of all floors within the perimeter of the outside walls, including basements. Attached covered walkways, patios, decks, garages, attics with a ceiling height of 6’6” or more shall also be included in the calculation of the GFA. The GFA for pre-fabricated buildings shall include those areas that are not part of the pre-manufactured structure, including but not limited to; decks, covered walkways and garages or additions to the structure that are note part of the manufacturer’s product.
- MFD** – “Multi-Family Dwelling” (i.e. apartments / quadraplexes)
- PRD** - “Planned Residential Development”
- R.A.N.** - “Radio Frequency Access Node” – A network of antennas transporting many different service providers’ radio frequency signals (i.e. a small cell wireless node on a utility pole)
- SF** – “Square Feet”
- SFD** – “Single Family Dwelling”
