## TOWNSHIP OF HILLSIDE ORDINANCE NUMBER O-18-15

CAPITAL ORDINANCE PROVIDING FOR THE ACQUISITION OF LIFTS FOR THE DEPARTMENT OF PUBLIC WORKS GARAGE, IN AND BY THE TOWNSHIP OF HILLSIDE, IN THE COUNTY OF UNION, STATE OF NEW JERSEY; APPROPRIATING \$54,525.00 THEREFOR TO PAY THE COST THEREOF

NOW, THEREFORE, BE IT ORDAINED AND ENACTED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HILLSIDE, IN THE COUNTY OF UNION, STATE OF NEW JERSEY (a majority of the full membership thereof affirmatively concurring), AS FOLLOWS:

**SECTION 1.** The capital purpose described in Section 2 of this capital ordinance is hereby authorized as a general capital purpose to be undertaken by the Township of Hillside, in the County of Union, State of New Jersey (the "Township"). For the said improvement or purpose stated in Section 2 hereof, there is hereby appropriated the sum of \$54,525.00 now available, or which shall be available, in the Capital Improvement Fund of the Township.

**SECTION 2.** The improvement and purpose hereby authorized is for the acquisition of lifts for the Department of Public Works garage, including, but not limited to, as applicable, all work materials, labor and appurtenances necessary therefor or incidental thereto and the decommission of an existing inground lift.

**SECTION 3.** The expenditure of \$54,525.00 from the Capital Improvement Fund of the Township for the purpose set forth in Section 2 hereof is hereby authorized and approved.

SECTION 4. The capital or temporary capital budget of the Township is hereby

amended to conform with the provisions of this capital ordinance to the extent of any

inconsistency herewith. In the event of any such inconsistency, a resolution in the form

promulgated by the Local Finance Board showing full detail of the amended capital budget

or temporary capital budget and capital programs as approved by the Director of the Division

of Local Government Services, New Jersey Department of Community Affairs will be on file

in the office of the Clerk and will be available for public inspection.

SECTION 5. This ordinance shall take effect after final adoption and approval

by the Mayor as provided in N.J.S.A. 40:69A-181.
