**ORDINANCE NUMBER O-20-12**

**AN ORDINANCE TO AMEND ORDINANCE O-426-78 ENTITLED AN ORDINANCE TO PROVIDE FOR THE ADOPTION OF RECLASSIFICATION AND COMPENSATION PLAN PREPARED BY THE NEW JERSEY DEPARTMENT OF CIVIL SERVICE COVERING THE OFFICERS AND EMPLOYEES OF THE TOWNSHIP OF HILLSIDE**

**WHEREAS**, SECTION §4-35 of the Hillside Township Code establishes the position Municipal Court Judge; and

**WHEREAS**, the same section sets forth that the salary shall be set forth in a Salary Ordinance; and

**WHEREAS**, Ordinance O-426-78 provided for the reclassification and compensation plan for employees of the Township of Hillside including both Chief Judge and Municipal Judge;

**NOW, THEREFORE BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HILLSIDE** that Ordinance O-426-78 entitled “An Ordinance to Provide for the Adoption of Reclassification and Compensation Plan Prepared by the New Jersey Department of Personnel Covering the Officers and Employees of the Township of Hillside” adopted March 21, 1978, be amended as follows:

**SECTION 1:** The salary for the positions set forth below shall be as follows:

- a. TITLE  
Chief Municipal Judge  
  
COMPENSATION—Salary Range  
\$25,000 to \$32,500 salary per annum  
  
EFFECTIVE DATE  
June 1, 2020

- b. TITLE  
Municipal Judge  
  
COMPENSATION—Salary Range  
\$20,000 to \$25,000 salary per annum  
  
EFFECTIVE DATE  
June 1, 2020

**BE IT FURTHER ORDAINED** that the Chief Municipal Judge shall be compensated by at least \$5,000 greater than the Municipal Judge based on the additional workload.

**SECTION 2:** All resolutions and/or ordinances or parts of thereof inconsistent herewith are hereby rescinded and/or repealed, but only to the extent of their inconsistency herewith.

**SECTION 3:** This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.





THE TOWNSHIP OF HILLSIDE: O-20-12**

**WHEREAS**, Ordinance O-426-78 provided for the reclassification and compensation plan for employees of the Township of Hillside including both Chief Judge and Municipal Judge;

**WHEREAS**, an Ordinance to amend Ordinance O-426-78 entitled An Ordinance To Provide For The Adoption of Reclassification And Compensation Plan Prepared By The New Jersey Department Of Civil Service Covering The Officers And Employees of the Township of Hillside designated as Ordinance Number **O-20-12** was introduced on July 13, 2020 and approved on July 28, 2020 by the Township Council of the Township of Hillside; and

**WHEREAS**, pursuant to N.J.S.A. 40:69A -41, the Mayor of the Township of Hillside may veto an ordinance approved by the Township Council by returning same to the Township Clerk within ten (10) days of the presentation of the ordinance to the mayor; and

**WHEREAS**, the Mayor of the Township of Hillside has returned Ordinance No. O-20-12 to the Township Clerk on August 19, 2020 within the time period required by statute and accompanied by her notice of rejection of same; and

**WHEREAS**, the Township Council of the Township of Hillside, upon reconsideration thereof, seeks and hereby resolves to override the Mayor's veto of Ordinance No. O-20-12 pursuant to the authority granted thereto under N.J.S.A. 40:69A-41; and

**NOW, THEREFORE, BE IT RESOLVED** by the Township Council of the Township of Hillside, County of Union, State of New Jersey, does hereby override the veto of Ordinance No.: O-20-12 by the Mayor of the Township of Hillside to the authority granted to the Township Council under N.J.S.A. 40:69A-41.
