## **ORDINANCE NUMBER O-21-07**

## ORDINANCE AMENDING CHAPTER 291 VEHICLES AND TRAFFIC, ARTICLE II – STOPPING, STANDING AND PARKING §17 "PARKING PROHIBITED AT ALL TIMES ON CERTAIN STREETS" TO ADD MCLEAN PLACE (BOTH SIDES) FROM ROUTE 22 TO EASTERN PARKWAY

WHEREAS, a major safety hazard has been created by parked cars on McLean Place located at Route 22 to Eastern Parkway such that parking on the Street must be eliminated at the identified location.

# NOW THEREFORE BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HILLSIDE THAT:

Chapter 291 Vehicles and Traffic, Article II Stopping, Standing and Parking §17 is hereby amended to add the following pertaining to McLean Place:

## Section 291-17 Parking prohibited at all times on certain streets.

| Name of Street | Side | Location                         |
|----------------|------|----------------------------------|
| McLean Place   | Both | From Route 22 to Eastern Parkway |

#### SEVERABILITY

If any provision of this Ordinance, or the application of any such provision to any person or circumstances, shall be held invalid, the remainder of this Ordinance to the extent it can be given effect, or the application of such provision to persons or circumstances other than those to which it is held invalid shall not be affected thereby, and to this extent the provisions of this Ordinance are severable.

#### REPEALER

All ordinances or parts of ordinances which are inconsistent with any provisions of this Ordinance are hereby repealed as to the extent of such inconsistencies.

#### **EFFECTIVE DATE**

This Ordinance shall become effective twenty (20) days following the final adoption thereof by the Township Council of the Township of Hillside and shall be published as required by law.
