ORDINANCE NUMBER O-22-17**

AN ORDINANCE TO AMEND ORDINANCE #426-78 ENTITLED AN ORDINANCE TO PROVIDE FOR THE ADOPTION OF RECLASSIFICATION AND COMPENSATION PLAN PREPARED BY THE NEW JERSEY DEPARTMENT OF CIVIL SERVICE COVERING THE OFFICERS AND EMPLOYEES OF THE TOWNSHIP OF HILLSIDE

BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF TOWNSHIP OF HILLSIDE that ordinance #L-426-78 entitled "An Ordinance to Provide for the Adoption of Reclassification and Compensation Plan Prepared by the New Jersey Department of Personnel Covering the Officers and Employees of the Township of Hillside" adopted March 21, 1978, be amended as follows:

SECTION 1: The said ordinance is modified to establish compensation for the positions as follows:

TITLE (Per Annum)	SALARY RANGE
Township Attorney (PT)	\$50,000 - \$80,000
First Assistant Township Attorney (PT)	\$25,000 - \$55,000

SECTION 2: All ordinances or parts of ordinances inconsistent herewith are hereby repealed.

SECTION 3: This Ordinance shall take effect upon final passage and publication in accordance with New Jersey law.
