ORDINANCE AMENDING PENALTIES FOR PARKING, AMENDING CHAPTER 291 VEHICLES AND TRAFFIC. ARTICLE 2. STOPPING, STANDING, AND PARKING, SUBSECTION 16

WHEREAS, The Township desires to <u>amend CHAPTER 291 VEHICLES AND TRAFFIC. ARTICLE 2.</u> STOPPING, STANDING, AND PARKING, SUBSECTION 16 to provide for penalties for orderly administration and enforcement against violations of this provision, which should carry higher penalties than those provided for under § 291-7.1.

# NOW THEREFORE BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF HILLSIDE THAT:

- 1. CHAPTER 291 VEHICLES AND TRAFFIC. ARTICLE 2. STOPPING, STANDING, AND PARKING, SECTION 291-16 shall be amended as follows:
  - <u>A.</u> No person shall park a vehicle upon any of the following streets or parts of streets between the hours specified on the days indicated:

B. Violations and penalties. Any person violating this section shall be subject to a fine of \$54, plus court costs, with no court appearance required.

THE BALANCE OF THE ORDINANCE SHALL REMAIN UNCHANGED EXCEPT AS STATED ABOVE.

## 2. SEVERABILITY

If any provision of this Ordinance, or the application of any such provision to any person or circumstances, shall be held invalid, the remainder of this Ordinance to the extent it can be given effect, or the application of such provision to persons or circumstances other than those to which it is held invalid shall not be affected thereby, and to this extent the provisions of this Ordinance are severable.

### 3. REPEALER

All ordinances or parts of ordinances which are inconsistent with any provisions of this Ordinance are hereby repealed as to the extent of such inconsistencies.

## 4. EFFECTIVE DATE

This Ordinance shall become effective twenty (20) days following the final adoption thereof by the Township Council of the Township of Hillside and shall be published as required by law.
