## ORDINANCE O-24-02

# ORDINANCE AMENDING CHAPTER 131 OF THE TOWNSHIP CODE, EMERGENCY MANAGEMENT, TO BE CONSISTENT WITH STATE STATUTE

**WHEREAS**, the current Township Code setting forth the residency qualifications of the municipal emergency management coordinator are more restrictive than the state statute requirements for residency qualifications of municipal emergency management coordinators; and

**WHEREAS**, the Township desires to modify the Township code to reflect the requirements of N.J.S.A. App.A:9-40.1, requiring that a municipal emergency management coordinator reside within the municipality *or* within a reasonable proximity of the municipality so as to ensure a prompt response or coordination of municipal resources for any local incident.

**NOW THEREFORE BE IT ORDAINED** by the Township Council of the Township of Howell, County of Monmouth, and State of New Jersey, as follows:

**SECTION 1.** Chapter 131 of the Howell Township code shall be amended with the following addition:

#### § 131-6 Director and Deputy Directors; appointment; term; qualifications.

- A. The Township Manager shall appoint a Director of the Howell Township Office of Emergency Services, in accordance with the New Jersey statutes, who shall be a person well versed and trained in planning operations involving the activities of many different agencies, which will operate to protect the public health, safety and welfare in the event of danger from enemy action or disaster as defined in this chapter. The Director shall be a resident of the Township, or reside within a reasonable proximity of the municipality to ensure a prompt response or coordination of municipal resources for any local incident. and The Director shall serve for a term of three years. As a condition of his or her appointment and his or her right to continue for the full term of his or her employment, he or she shall have successfully completed at the time of his or her appointment or within one year immediately following his or her appointment the current approved home study course and the basic emergency management workshop. Failure to fulfill such requirement within the period prescribed shall disqualify the individual from continuing the office of Director, and thereupon a vacancy in said office shall be deemed to have been created.
- B. The Emergency Services Director shall designate and appoint Deputy Directors, with the approval of the Township Manager, to assume the emergency duties of the Director in the event of his or her absence or inability to act. Wherever possible, such Deputy shall be appointed from among the salaried officers or employees of the Township.

#### SECTION 2. INCONSISTENT ORDINANCES

All other Ordinances or parts thereof inconsistent with the provisions of this Ordinance are hereby repealed as to such inconsistency.

#### **SECTION 3. SEVERABILITY**

If any section, paragraph, subdivision, clause or provision of this Ordinance shall be adjudged invalid, such adjudication shall apply only to the section, paragraph, subdivision, clause or provision so adjudged and the remainder of this Ordinance shall be deemed valid and effective.

#### **SECTION 4. EFFECTIVE DATE**

This Ordinance shall take effect upon its passage and publication according to law.

#### **NOTICE**
