ORDINANCE NO. 01-24

STATE OF WISCONSIN VILLAGE OF JOHNSON CREEK JEFFERSON COUNTY

AN ORDINANCE REPEALING AND RECREATING SECTIONS 193-2 AND 193-8 G. OF THE MUNICIPAL CODE

THE VILLAGE BOARD OF THE VILLAGE OF JOHNSON CREEK, JEFFERSON COUNTY, WISCONSIN, DOES ORDAIN AS FOLLOWS:

<u>SECTION 1</u>: Section 193-2 is hereby repealed and recreated to read as follows:

§ 193-2 Exemptions.

This chapter or any part thereof shall not apply to newspaper delivery persons; merchants delivering goods in the regular course of business; vendors of frozen foods, bakery goods, or grocery products to only regular customers on established routes; minors who are residents of the Johnson Creek School District; mobile food vendors marketing to employees of a specific business during a meal period, mobile food vendors catering private events, or persons holding a state license issued pursuant to § 440.51, Wis. Stats., but such persons shall comply with the provisions of § 193-8 of this chapter.

<u>SECTION 2</u>: Section 193-8 G. is hereby repealed and recreated to read as follows:

G. Licenses for mobile food vendors to engage in mobile food sales activities shall only be issued if such activities occur on privately owned commercial or industrial property, and in accordance with the Zoning Code of the Village. Licenses issued to mobile food vendors operating on publicly owned property shall be allowed with authorization from the governing body of the public entity owning or controlling the property. Any license issued for a mobile food vendor shall identify the location on the lot or private property on which mobile food sales activities can be conducted. No license authorizing mobile food vendor sales may be issued for a private lot, parcel or any property which is owned or used for residential purposes.

<u>SECTION 3</u>: All ordinances or parts of ordinances conflicting with or contravening the provisions of this Ordinance are hereby repealed.

SECTION 4: This Ordinance shall take effect upon passage and posting as provided by law.
