Chapter 195 Taxation
Article VI Partial Real Property Tax Exemptions for Persons with Disabilities and Limited Incomes

§ 195-30. Partial Exemption for Persons with Disabilities and Limited Incomes.

- a. Pursuant to the provisions of Section 459-c of the Real Property Tax Law, real property located in the Village which is owned by one or more persons with disabilities, or real property owned by a husband, wife or both, or by siblings, at least one of whom has a disability, and whose income as hereafter defined, is limited by reason of such disability, shall be exempt from taxation by the Village to the extent provided in the following schedule:

Annual Income	Percentage of Assessed Valuation Exempt from Taxation
\$0 to \$23,000.00	50%
\$23,000.01 to \$23,999.99	45%
\$24,000.00 to \$24,999.99	40%
\$25,000.00 to \$25,999.99	35%
\$26,000.00 to \$26,899.99	30%
\$26,900.00 to \$27,799.99	25%
\$27,800.00 to \$28,699.99	20%
\$28,700.00 to \$29,599.99	15%
\$29,600.00 to \$30,499.99	10%
\$30,500.00 to \$31,399.99	5%

b. Exemption from taxation for school purposes shall not be granted in the case of real property where a child resides if such child attends a public school of elementary or secondary education.
