LOCAL LAW 2024 - 1 AMENDING THE CONDITIONS FOR APPROVAL OF INDEPENDENT ELECTRICAL INSPECTION FIRMS

ENACTING A LOCAL LAW

The **TOWN BOARD OF THE TOWN OF MANLIUS**, in the County of Onondaga, State of New York, met in regular session at the Town Hall in the Town of Manlius, located at 301 Brooklea Drive in the Village of Fayetteville, County of Onondaga, State of New York, and virtually on the platform commonly referred to as Zoom, the Town Facebook page and YouTube on the 14th of February, 2024, at 6:30 p.m.

The following resolution was moved, seconded, and adopted:

WHEREAS, the ability to contract with third parties for professional services for the benefit of the Town of Manlius is important to the Town Board; and,

WHEREAS, the Town of Manlius must adhere to the schedule of limits concerning liability insurance policies of third parties contracted to service the Town of Manlius; and,

WHEREAS, the Town of Manlius wishes to amend its existing conditions relating to the approval of independent electrical inspection firms; and,

WHEREAS, a Local Law has been introduced before the Board, to wit: Local Law No. 2024 - 1, entitled "A Local Law Amending the Conditions for Approval of Independent Electrical Inspection Firms" as follows:

LOCAL LAW 2024 - 1, A LOCAL LAW AMENDING THE CONDITIONS FOR APPROVAL OF INDEPENDENT ELECTRICAL INSPECTION FIRMS

BE IT ORDAINED AND ENACTED by the Town Board of the Town of Manlius, County of Onondaga, State of New York, as follows:

<u>Section 1</u>. That Chapter 59, Section 59-19 is hereby amended as follows:

§ 59-19. Conditions for approval of independent electrical inspection firms.

The Town Board of the Town of Manlius may, from time to time, approve independent electrical inspection firms to see that the properties and construction in the Town of Manlius conform to the New York State Uniform Fire Prevention and Building Code and the local laws, rules and regulations as the Town of Manlius shall deem applied. The approved independent electrical inspection firms shall be those that:

- A. File with and keep in force a liability policy issued by a company licensed to do business in New York State according to the minimum insurance requirements set forth by the insurance agent for the Town. All such insurance policies will be reviewed by the insurance agent for the Town prior to approval as an independent inspection firm with such approval being made in writing, and, being made part of the file. The liability policy shall name the Town of Manlius as an additional insured and shall by its terms protect the Town of Manlius from any and all liability, active or passive, or claims or causes of action for personal injury or property damage that arise out of the actions of a member or representative of the approved electrical inspection firm performing electrical inspections in the Town of Manlius for or on the behalf of the Town of Manlius or to enforce code compliance with the New York State Uniform Fire Prevention and Building Code and the applicable standards of this chapter or any other code.
- B. Shall be accepted by the utilities serving the Town of Manlius, Onondaga County, New York State.
- C. In the sole opinion of the Town Board, maintain a suitable office and ample, trained staff to service the Town of Manlius and its residents.
- D. In the sole opinion of the Town Board, has performed satisfactorily in services rendered in the Town of Manlius and remains capable of performing such services.

<u>Section 2.</u> This local law shall take upon the filing with the Secretary of State.

 $WHEREAS, on \ February \ 14, 2024, the \ Town \ Board \ held \ a \ public \ hearing \ regarding$ the proposed Local Law.

NOW, THEREFORE, BE IT

RESOLVED, that Local Law 2024-1 is hereby approved and enacted; and be it further

RESOLVED, that the Town Clerk is directed to file Local Law 2024-1 with the Secretary of State within 20 days of the date set forth herein.
