

WHEREAS, the Town of Manlius wishes to amend its existing floodplain management regulations to incorporate the map updates provided by the New York State Department of Environmental Conservation; and,

WHEREAS, a Local Law has been introduced before the Board, to wit: Local Law No. 2024 - 2, entitled "A Local Law To Update The Town's Existing Floodplain Management Regulations" as follows:

LOCAL LAW 2024 -2, A LOCAL LAW TO UPDATE THE TOWN'S EXISTING FLOODPLAIN MANAGEMENT REGULATIONS

BE IT ORDAINED AND ENACTED by the Town Board of the Town of Manlius, County of Onondaga, State of New York, as follows:

Section 1. That Chapter 72, Section 72-6 is hereby amended as follows:

§ 72-6. Basis for establishing areas of special flood hazard.

A. The areas of special flood hazard for the Town of Manlius, Community Number 360584, are identified and defined on the following documents prepared by the Federal Emergency Management Agency:

(1) Flood Insurance Rate Map Panel Numbers:

36067C0231F, 36067C0232F, 36067C0233F, 36067C0234F, 36067C0241F,

whose effective date is November 4, 2016, and any subsequent revisions to these map panels that do not affect areas under our community's jurisdiction.

(2) A scientific and engineering report entitled "Flood Insurance Study, Onondaga County, New York, All Jurisdictions" dated November 4, 2016.

(3) Letter of Map Revision (LOMR) Case No. 22-02-0141P, effective March 27, 2024, revising FIRM panel numbers 36067C0242F and 36067C0244F, Flood Insurance Study Floodway Data Table 9, and Flood Insurance Study Profile 116P.

B. The above documents are hereby adopted and declared to be a part of this chapter and the Code of the Town of Manlius. The Flood Insurance Study and/or maps are on file at:
