**WHEREAS,** N.J.S.A 33 allows for the annual fee for renewal of a Plenary Retail Consumption License and a Plenary Retail Distribution License to be raised or lowered no more than 20% from the fee charged the preceding year;

WHEREAS, the last change in fee ordinance was in 2020;

Section 1. The following sections of the Code of the Township of Mansfield are hereby amended to read as follows:

Section 2. The provision of this section with respect to the limitation on the number of licenses shall not apply to the renewal or transfer of licenses presently issued.

Section 3. This Ordinance shall take effect immediately upon publication as provided by law.
