## MUNICIPALITY OF MURRYSVILLE WESTMORELAND COUNTY, PENNSYLVANIA ORDINANCE NO. 1083-23

AN ORDINANCE OF THE MUNICIPALITY OF MURRYSVILLE, WESTMORELAND COUNTY, PENNSYLVANIA AMENDING MUNICIPALITY OF MURRYSVILLE ORDINANCE NO. 1025-20 REGARDING UNACCEPTABLE SANITARY SEWAGE.

WHEREAS, the Municipality of Murrysville, ("Murrysville") Westmoreland County, Pennsylvania passed Ordinance No. 1025-20, hereinafter ("Ordinance") concerning various issues regarding public sanitary sewage sewers; and

WHEREAS, the Ordinance in Section 10 provides that "unacceptable sanitary sewage" shall have the same definition as set forth in FTMSA's Sewer Systems Rules and Regulations; and

WHEREAS, the Ordinance does not specifically prohibit any person, firm or corporation from disposing into the public sanitary sewer "unacceptable sanitary sewage" as so defined; and

WHEREAS, Murrysville desires to amend Ordinance No. 1025-20 to provide that it shall be unlawful for any person, firm or corporation to dispose "unacceptable sanitary sewage" into the public sanitary sewers.

**NOW, THEREFORE, BE IT ORDAINED AND ENACTED** by the Municipality of Murrysville, Westmoreland County, Pennsylvania, and it is hereby ordained and enacted by the authority of the same as follows:

- 1. Section 10 of the Ordinance titled "Unacceptable Sanitary Sewage Defined" shall be eliminated in its entirety and replaced with the following:
  - 10. Unacceptable Sanitary Sewage Defined and Prohibited. "Unacceptable Sanitary Sewage" for the purposes of this Ordinance shall have the same definition as that which is set forth in FTMSA's Sewer System Rules and Regulations, said Rules and Regulations being hereby approved by Murrysville and held to be applicable to all users of the aforementioned public sanitary sewers. It shall be unlawful for any person, firm or corporation to dispose, permit, allow or cause to enter into the public sanitary sewers Unacceptable Sanitary Sewage.
- 2. All sections and parts of this Ordinance are severable and if any section or portion thereof shall be declared invalid, the same shall not affect the validity of any and all other sections and portions.
- 3. This Ordinance No. 1083-23 shall be effective five (5) days after passage.
