**AN ORDINANCE TO AMEND CHAPTER 187 §9(B) OF THE CODE OF THE**  
**BOROUGH OF NORTH ARLINGTON ENTITLED "VEHICLES AND TRAFFIC"**  
**PROVIDING FOR A HANDICAPPED PARKING SPACE**  
(233 Stover Ave.)

**WHEREAS**, the Property Owner has made application to the Department of Police of the Borough and the Police Department reviewed the application and indicated that requirements have been met for handicapped parking at the subject site; and


**WHEREAS**, the Mayor and Council have determined to amend Chapter 187 §9(B) of the Code of the Borough of North Arlington; and

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Council of the Borough of North Arlington, County of Bergen, State of New Jersey, that the following be designated as a handicapped parking space:
