ORDINANCE NO. 2333
BOROUGH OF NORTH ARLINGTON
BERGEN COUNTY, NEW JERSEY

AN ORDINANCE TO AMEND CHAPTER 187 OF THE CODE OF THE
BOROUGH OF NORTH ARLINGTON ENTITLED "VEHICLES AND TRAFFIC"

WHEREAS, the Mayor and Council have determined that there is a need to amend Chapter 187 of the Code of the Borough of North Arlington entitled "Vehicles and Traffic"; and

WHEREAS, the Mayor and Council of the Borough of North Arlington have determined that there is a need to amend Chapter 187, Section 22 entitled "Snow Emergency"; and

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of North Arlington, County of Bergen, State of New Jersey, that Chapter 187, Section 22 entitled “Snow Emergency” and all amendments thereto are hereby repealed in their entirety and are replaced with the following:

- A. No person shall park a vehicle upon the following described streets or parts of streets thereof listed below, whenever snow has fallen and the accumulation is such that it covers the street or highway.

Arlington Ave - Entire Length- North Side
Astor Ave - Entire Length -North Side
Avon Pl - Entire Length- North Side
Bathhurst Ave - Hedden Ter to dead end- East Side
Beaver Ave - Ridge Rd. to Rutherford Pl - Both Sides
Beech St - school parking cut out area- West Side
Belmount Ave - Ridge Rd to York Rd. - Both Sides
Canterbury Ave - Ridge Rd to Schuyler Ave - Both Sides
Cedar St -Entire Length-West Side
Fisher Pl - Entire Length -West Side
Greco Terrace-Entire Length - West Side
Harding Ave - Ridge Rd to Rutherford Pl- North Side
Hillside Ave - Entire Length -Both Sides
Jason Way - Entire Length outer curb line - East Side
Leonard Pl -First St. to dead end-South Side
Madison St - Leonard Pl to the dead end -East Side
Morgan Pl - Entire Length - West Side

Morton Pl - Entire Length- North Side
Norwood Terrace - Entire Length-East side
Pershing Pl - Entire Length -West Side
Pine St - Entire Length -West Side
Prospect Ave - Belleville Pike to Belmont Av -Both Sides
Pulaski Dr - Second St. to dead end- North Side
Ridge Rd - Belleville Pike to Union Ave- Both Sides
Renner Pl - Entire Length- North Side
Roosevelt Pl - Entire Length- East Side
Rutherford Pl- Entire Length -West side
Stratford Pl - Entire Length -North Side
Union Pl - Harding Ave to dead end -West Side

- B. The above parking prohibitions shall remain in effect after the snow has ceased until the streets have been plowed sufficiently and to the extent that parking will not interfere with the normal flow of traffic.

IT IS FURTHER ORDAINED that the remainder of Chapter 187 of the Code of the Borough of North Arlington shall remain in full force and effect; and

IT IS FURTHER ORDAINED that all ordinances or parts of ordinances inconsistent herewith are hereby repealed; and

IT IS FURTHER ORDAINED that if any parts, sections, provisions, or the total of any of the above provisions are held to be invalid or unenforceable in any court, the findings or judgments of which court are applicable to the State of New Jersey, the balance and remainder of

such provisions shall remain in full force and effect as an Ordinance of the Borough of North
Arlington; and

IT IS FURTHER ORDAINED that this Ordinance shall become effective twenty (20)
days after the adoption and publication according to law.
