ORDINANCE NO. 2334
BOROUGH OF NORTH ARLINGTON
BERGEN COUNTY, NEW JERSEY

AN ORDINANCE APPROPRIATING \$140,000 FROM GENERAL CAPITAL FUND BALANCE FOR THE INSTALLATION OF A NEW ROOF FOR BOROUGH HALL AND THE SENIOR CITIZEN CENTER FOR AND BY THE BOROUGH OF NORTH ARLINGTON, IN THE COUNTY OF BERGEN, NEW JERSEY.

BE IT ORDAINED by the Governing Body of the Borough of North Arlington, County of Bergen, New Jersey as follows:

Section 1. The improvement described in Paragraph 3 of this Ordinance is authorized and declared to be necessary and useful for municipal purposes.

Section 2. There is hereby appropriated for said purposes the sum of \$140,000 from General Capital Fund Balance. Said sum being inclusive of all appropriations heretofore made therefore.

Section 3. That the improvement hereby authorized and the purpose for which this appropriation is made is for the installation of new roof for Borough Hall and the Senior Citizen Center.


Section 4. That the estimated cost which is hereby appropriated from General Capital Fund Balance is \$140,000.
