**AN ORDINANCE TO AMEND CHAPTER 187 §9(B) OF THE CODE OF THE  
BOROUGH OF NORTH ARLINGTON ENTITLED "VEHICLES AND TRAFFIC"  
PROVIDING FOR A HANDICAPPED PARKING SPACE**

**WHEREAS**, the Property Owner has made application to the Department of Police of the Borough and the Police Department reviewed the application and indicated that requirements have been met for handicapped parking at the subject site; and


**WHEREAS**, the Mayor and Council have determined to amend Chapter 187 §9(B) of the Code of the Borough of North Arlington; and

**NOW THEREFORE BE IT ORDAINED** by the Mayor and Council of the Borough of North Arlington, County of Bergen, State of New Jersey, that the following be designated as a handicapped parking space:

<u>Location</u>	<u>Side</u>	<u>Description</u>
125 Hedden Terrace	West	Beginning at a point 23 feet south of the crosswalk and curb line at the corner of Hedden Terrace and Bathurst Avenue and extending to a point 20 feet south there from along Bathurst Avenue.

**IT IS FURTHER ORDAINED** that the remainder of Chapter 187 §9(B) of the Code of the Borough of North Arlington shall remain in full force and effect.
