**ORDINANCE NO. 3535**

**ORDINANCE PROVIDING FOR IMPROVEMENTS TO MONSIGNOR OWENS PARK, IN THE TOWNSHIP OF NUTLEY, IN THE COUNTY OF ESSEX, NEW JERSEY APPROPRIATING \$1,028,755.00 THEREFOR FROM GRANT MONIES RECEIVED FROM THE NEW JERSEY DEPARTMENT OF ENVIRONMENTAL PROTECTION GREEN ACRES GRANT FOR THE COST THEREOF.**

**BE IT ORDAINED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF NUTLEY, IN THE COUNTY OF ESSEX, NEW JERSEY, AS FOLLOWS:**

Section 1. The improvement described in Section 2 of this ordinance is hereby authorized as a general improvement to be made or acquired by the Township of Nutley, New Jersey, and there is hereby appropriated therefor the sum of \$1,028,755.00 for the improvement or purpose described therein which amount is made available from the Transportation Trust Fund monies received from the New Jersey Department of Environmental Protection.

Section 2. The improvement hereby authorized and purpose for the financing of which the appropriation is made as provided in Section 1 of this ordinance is the improvement of Monsignor Owens Park, including all work and materials necessary therefore or incidental thereto.

Section 3. The capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget and
