ORDINANCE NO. 1239-23

**AN ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 119,
ARTICLE III, “RECREATION PROGRAM FEES” OF
THE CODE OF THE BOROUGH OF OLD TAPPAN TO AMEND THE
FEES CHARGED THEREIN**

BE IT ORDAINED by the Mayor and Council of the Borough of Old Tappan, County of Bergen, State of New Jersey, as follows:

Section 1. Chapter 119-9, Article II, entitled “Recreation Program Fees” is amended by the following:

119-9. Registration Fees.

A. Basketball

(1) Winter Recreation:

K - 2 nd Grade	\$80.00-150.00
3 rd - 8 th Grade	\$100.00-175.00
Winter/Summer	\$125.00-175.00
Late Fee	\$25.00

(2) Winter Travel:

2 nd - 8 th Grade	\$200.00-250.00 (Registration Fee)
2 nd - 8 th Grade	\$150.00-\$250.00 per child coaching fee (if needed) in addition to the Registration Fee

(3) Pre-season Travel Tournament Play - \$50.00-100.00

(4) Summer Recreation:

3 rd - 8 th Grade	\$75.00-175.00
Winter/Summer	\$125.00- 175.00
Late Fee	\$25.00

(5) Men's 30 and over

Spring Program:	\$85.00- 150.00
Fall Program:	\$85.00- 150.00

(6) Uniform Fee

Fee for Travel Basketball Uniforms	\$50.00- 150.00

H. Pickleball

(1) Individual Adult - \$45.00 - \$60.00

(2) Senior Citizen (65 years old +) \$35.00 - \$60.00

(3) Youth (12 years old - 17 years old) \$35.00 - \$60.00

(4) Under 12 years old - Free (must be accompanied by an adult)

Section 2. Repealer.

All ordinances or parts of ordinances inconsistent or in conflict with this Ordinance are hereby repealed as to said inconsistencies and conflicts.

Section 3. Severability.

If any section, part of any section, or clause or phrase of this ordinance is for any reason held to be invalid or unconstitutional, such decision shall not affect the remaining provisions of this ordinance. The governing body of the Borough of Old Tappan declares that it would have passed

the ordinance and each section thereof, irrespective of the fact that any one or more of the subsections, sentences, clauses or phrases may be declared unconstitutional or invalid.

Section 4. Effective Date.

This ordinance shall take immediate effect upon passage and publication according to law.
