Section 120-34. Override

Pursuant to the provisions of General Municipal Law Section 3-c Subdivision 5, the Board of Trustees of the Village of Pomona may adopt a budget for the June 1, 2019- May 31, 2020 Fiscal Year that requires a tax levy that is greater than tax levy limit for such Fiscal Year.

Section 2. This local law shall take effect only if adopted by an affirmative vote of sixty percent of the total voting power of the Board of Trustees and upon filng with the Secretary of State.
