**FURTHER REGULATING THE SALARIES/WAGES OF
APPOINTIVE OFFICE HOLDERS, ELECTED OFFICE HOLDERS,
AND EMPLOYEES OF THE CITY OF POTTSVILLE.**

THE CITY COUNCIL OF THE CITY OF POTTSVILLE DOES HEREBY ORDAIN:

Section 1. That from and after the first day of January Two Thousand Twenty-Four (2024), the appointive office holders and employees of the City of Pottsville, hereinafter named, shall so long as such positions are continued, receive as compensation for their services, salaries or wages in the amounts hereinafter stated.

Section 3. That said salaries/wages shall be due and payable weekly.

Section 4. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed.

Section 5. This Ordinance shall become effective upon final passage and shall apply retroactive to January 1, 2024.


