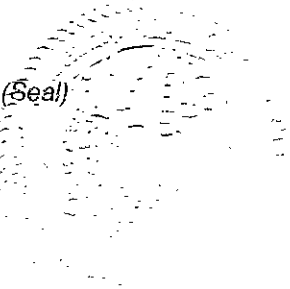

## **Local Law modifying the Charter with regard to Memorial Day observances**

BE IT ENACTED, by the Council of the City of Rochester as follows:

Section 1. Chapter 755 of the Laws of 1907, entitled "An Act Constituting the Charter of the City of Rochester", as amended, is hereby further amended in Section 3-11, General City expenses (annual estimate), to read in its entirety as follows:

The estimate of expenditures may contain an estimate of funds required for a contingent appropriation to pay general expenses of the City, and may contain a sum not less than \$1,500 nor exceeding ~~\$8,500~~ \$10,000 for the purpose of paying the expenses of a proper observance of Memorial Day, to be expended under the direction of the various veteran organizations of the City.

Section 2. This local law shall take effect immediately upon filing in the Office of the Secretary of State as provided by Section 27 of the New York State Municipal Home Rule Law.
