ORDINANCE NO. 490

AN ORDINANCE TO AMEND SECTIONS §21-14 OF THE ROCKWOOD CITY CODE TO REMOVE FOWL FROM THE LIST OF ANIMALS THAT MAY BE KEPT IN THE CITY

<u>Section 1.</u> That Chapter 21: Animals, Section 21-14 of the Rockwood City Code is hereby amended to provide as follows:

"Sec. 21-14. Certain animals prohibited

No person shall keep or house any animal or domestic fowl within the City, except dogs, cats, birds or animals commonly classified as pets.

<u>Section 2</u>. Saving Clause. Nothing in this Ordinance or in the Code hereby adopted shall be construed to affect any suit or proceeding pending in any court, or any rights acquired, or liability incurred, or any cause or causes of action acquired or existing, under any act or ordinance hereby repealed; nor shall any just or legal right or remedy of any character be lost, impaired or affected by this Ordinance.

<u>Section 3</u>. Severability. Should any word, sentence, phrase or any portion of this Ordinance be held in a manner invalid by any court of competent jurisdiction or by any state agency having authority to do so for any reason whatsoever, such holdings shall be construed and limited to such work, sentence, phrase or any portion of the Ordinance held to be so invalid shall not be construed as affecting the validity of any of the remaining words, sentences, phrases or portions of this Ordinance.

<u>Section 4.</u> Conflicting Ordinances. All prior existing ordinances adopted by the City of Rockwood inconsistent or in conflict with the provisions of this Ordinance are, to the extent of such conflict or inconsistency, hereby expressly repealed.

<u>Section 5.</u> Repealed. All ordinances or parts of ordinances in conflict herewith are hereby determined to be repealed.
