AN ORDINANCE AMENDING CHAPTER 134-3 OF THE BOROUGH CODE OF THE BOROUGH OF SADDLE RIVER RELATING TO CERTAIN FEES RELATING TO LICENSES AND PERMITS ISSUED BY THE BOROUGH OF SADDLE RIVER

1. BE IT ORDAINED, by the Mayor and Council of the Borough of Saddle River, that the following amendments to Section 134-3 of the Saddle River Code relating to Licenses and Permits issued by the Borough of Saddle River be adopted (amendments underlined):

3.If any section, subsection, part, clause or phrase of this Ordinance shall be declared invalid by judgment of any court of competent jurisdiction, such section, subsection, part, clause or phrase shall be deemed to be severable from the remainder of this Ordinance.

4.This Ordinance shall take effect immediately upon final passage and publication as required by law.
