CITY OF SALEM ORDINANCE 24-02

ORDINANCE AMENDING CHAPTER 172 OF THE CODE OF THE CITY OF SALEM, NEW JERSEY ENTITLED "RENTAL OF RESIDENTIAL UNITS" AS ADOPTED BY THE CITY COUNCIL OF THE CITY OF SALEM BY WAY OF ORD. NO. 98-27 ON DECEMBER 7, 1998

WHEREAS, Ordinance #98-27 was adopted on December 7, 1998 to regulate the rental of residential units in the City of Salem ("City").

WHEREAS, from time to time, the City reviews its ordinances and wishes at this time to amend Chapter 172 of the Code of the City of Salem.

NOW, THEREFORE, BE IT ORDAINED BY THE COMMON COUNCIL OF THE CITY OF SALEM:

Section 1. The above-mentioned recitals are incorporated herein as though fully set forth at length.

Section 2. Chapter 172 of the Code of the City of Salem is hereby amended as follows:

a. §172-5(E)(1)

Third sentence of §172-5(E)(1) currently reads: "The penalty will be \$100 payable to the Department of Inspections and Permits for each day the unit is in violation."

To be amended to: "The penalty will be \$50 per week payable to the Department of Inspections and Permits for each week the unit is in violation."

- b. Remove current §172-5(F) and replace with the following:
- F. "No rental unit certificate shall be issued unless the real estate taxes, water and sewer charges, all Municipal Court fees associated with the rental unit and record owner, and/or other municipal assessments or charges due to the City of Salem associated with the rental unit premises are paid current in accordance with Chapter 135, Licenses and Permits, of this Code."
