SECTION 1. PURPOSE AND INTENT

In 2004 and 2005 the Town of Schaghticoke adopted a Comprehensive Plan and enacted an updated Zoning Law. The Town has been approached by Dean Heer whose family owns or has an interest in a parcel of land at 40 Hansen Road (Tax Map Parcel 71.-1-11 (4.67 acres)). The land is currently zoned as Residential District (R). The applicant has requested that the Town Board revise the zoning map to rezone the parcel to allow for other commercial uses.

SECTION 2. AUTHORITY

This local law is enacted pursuant to the provisions of section 10 of the Municipal Home Rule Law and Town of Schaghticoke Zoning Law Article XII.

SECTION 3. APPLICATION

The Zoning Map of the Town of Schaghticoke is hereby amended to change the zoning of Tax Map Parcel 71.-1-11 (4.67 acres) from Residential District (R) to Hamlet District (HD) as noted on the attached exhibit.

SECTION 4. REPEAL

All ordinances, local laws and parts thereof inconsistent with this Local Law are hereby repealed.

SECTION 5. SEVERABILITY

The invalidity of any word, section, clause, paragraph, sentence, part or provision of this local law shall not affect the validity of any other part of this local law which can be given effect.

SECTION 6. EFFECTIVE DATE

This local law shall take effect immediately upon the filing of such law with the office of the New York Secretary of State in accordance with section 27 of the Municipal Home Rule Law.

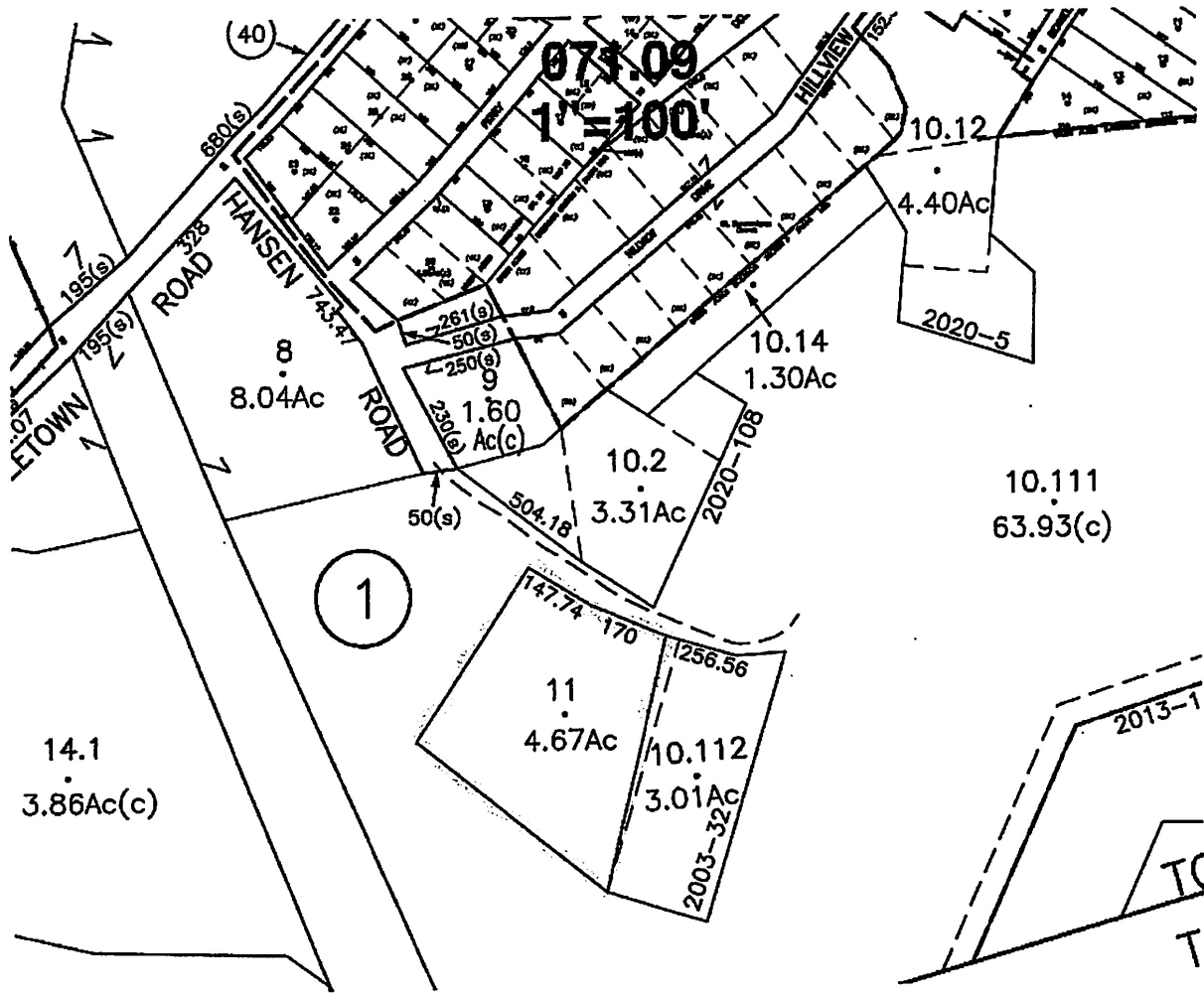
