SECTION 1. PURPOSE AND INTENT

In 2004 and 2005 the Town of Schaghticoke adopted a Comprehensive Plan and enacted an updated Zoning Law. The Town has been approached by Dean Heer whose family owns or has an interest in a parcel of land at 40 Hansen Road (Tax Map Parcel 71.09-1-11 (4.67 acres)). The land is currently zoned as Residential District (R). The applicant has requested that the Town Board revise the zoning map to rezone the parcel to allow for other commercial uses. The Planning Board has suggested that the additional lands in the vicinity also be rezoned to Hamlet, given that they abut the existing Hamlet District.

SECTION 2. AUTHORITY

This local law is enacted pursuant to the provisions of section 10 of the Municipal Home Rule Law and Town of Schaghticoke Zoning Law Article XII.
