

ORDINANCE NO. 2019-05

AN ORDINANCE TO AMEND THE CODE OF THE TOWNSHIP OF SWATARA, CHAPTER 271, THEREOF ENTITLED "VEHICLES AND TRAFFIC," TO ESTABLISH SPECIAL PURPOSE PARKING ZONES, TO ELIMINATE SPECIAL PARKING ZONES, TO PROHIBIT PARKING ON CERTAIN STREETS, AND ESTABLISH A STOP INTERSECTIONS

BE IT ORDAINED AND ENACTED by the Board of Commissioners of the Township of Swatara, County of Dauphin, Commonwealth of Pennsylvania, as follows:

SECTION 1. Chapter 271, Article IV, §271-35, "Special Purpose Parking Zones Established; Parking Otherwise Prohibited," is hereby amended by the inclusion under the name of highway, Side of Street, Authorized Purpose of Vehicle and Location, the following:

HIGHWAY	SIDE	AUTHORIZED PURPOSE OF VEHICLE (Handicapped Parking)	LOCATION
1257 Main Street	West	Tia Saxbie	Beginning at a point on the west side of Main Street at a point 42 feet north of the northwest corner of the intersection of main Street and Pleasant Avenue and extending 20 feet north along the frontage of 1257 Main Street

SECTION 2. Chapter 271, Article IV, §271-35, "Special Purpose Parking Zones Established; Parking Otherwise Prohibited," is hereby amended by the elimination under the name of Highway, Side of Street, Authorized Purpose of Vehicle and Location, the following:

HIGHWAY	SIDE	AUTHORIZED PURPOSE OF VEHICLE (Handicapped Parking)	LOCATION
1257 Main Street	West	Tia Saxbie	Beginning at a point on the west side of Main Street at a point 42 feet north of the northwest corner of the intersection of main Street and Pleasant Avenue and extending 20 feet north along the frontage of 1257 Main Street
462 2 nd Street	Southeast	Patricia Marston	Beginning at a point, said point being Located 64 feet southwest of the southwestern corner of the intersection of Boyer Street and 2 nd Street; thence continuing along the southeastern line of 2 nd Street, in a southwestern direction, a distance of 20 feet; being a portion of the frontage of 462 2 nd Street

SECTION 3. Chapter 271, Article IV, "General Parking Regulations," §271-31, "Parking prohibited at all times in certain locations," is hereby amended by the addition thereto of the following:

HIGHWAY	SIDE	BETWEEN
Sue Drive	Northeast	Beginning at a point at the northeast corner of the Intersection of Sue Drive and Somerset Street, extending 65 feet to the southeast along the northeast side of Sue Drive
Sue Drive	Northwest	Beginning at a point at the northwest corner of the Intersection of Sue Drive and Somerset Street, extending 32 feet to the west along the north side of Somerset Street

SECTION 5. Chapter 271, Article II, "Traffic Regulations," §271-22, "Stop Intersections Established," is hereby amended by the addition thereto of the following:

HIGHWAY	LOCATION
Davids Road	On Davids Road, on the eastbound corner of the intersection of Gaynor Lane and Davids Road for eastbound traffic
Wilhelm Road	On Wilhelm Road, on the southeast side of Wilhelm Road at the Intersection of Sharon Street and Wilhelm Road for northbound traffic
