AN ORDINANCE AMENDING AND SUPPLEMENTING TRENTON CITY CODE SECTION 2-6 (DEPARTMENTS)

presents the following Ordinance:

WHEREAS, it has been determined that the Office of the City Clerk was erroneously included in Trenton City Code Section 2-6 as a Department of the City of Trenton; and

WHEREAS, pursuant to N.J.S.A. 40:69A-43(a), the City Clerk holds an "Office" and is appointed by the City Council for a three-year term (N.J.S.A. 40A:9-133 and N.J.S.A. 40:69A-38); is not appointed by the Mayor as are all other Directors and does not serve for the term of the Mayor; and is not removable by the Mayor as are all other Department Heads (N.J.S.A. 40:69A-43)

NOW IT IS HEREBY ORDAINED by the City Council of the City of Trenton that Trenton City Code Section 2-6A is deleted in its entirety and is amended, revised and supplemented to read as follows:

2-6A:

Councilman /woman

The administration, functions, powers and duties of the City are allocated and assigned among and within the Departments established and constituted by this Chapter as follows:

Department of Administration

- (1) Department of Finance
- (2) Department of Law
- (3) Department of Housing and Economic Development/Inspections
- (4) Department of Recreation, Natural Resources and Culture
- (5) Department of Public Works
- (6) Department of Water and Sewer
- (7) Department of Health and Human Services
- (8) Department of Fire and Emergency Services
- (9) Police Department

AND IT IS FURTHER ORDAINED that any Ordinances inconsistent herewith are hereby repealed to the extent of such inconsistency;

AND IT IS FURTHER ORDAINED that this Ordinance shall take effect pursuant to NJSA 40:69A-181 and other applicable law.
