## AN ORDINANCE UNDER CHAPTER 87 OF THE CODE OF THE TOWNSHIP OF WASHINGTON SETTING FORTH THE RATE OF CLOTHING ALLOWANCE OF OFFICERS AND FIREFIGHTERS OF THE FIRE DEPARTMENT IN SAID MUNICIPALITY FOR THE YEAR 2023

BE IT ORDAINED, by the Township Council of the Township of Washington, in the County of Bergen, New Jersey that the clothing allowance rates are hereby established for officers and firefighters of the Township of Washington Fire Department for the year 2023 as follows:

1.	Fire Department Uniform Allowance	<u>Payable Per Annum</u> <u>in December</u>		
	All persons holding positions in the Office of Fire Protection shall be paid a clothing allowance in the amount set forth herein provided said persons have had more than 50% attendance at public fire duty and drill. If the person entitled to an allowance is a paid employee with the Township, such allowance will be paid through the payroll system.	725.00		
2.	The following Fire Department Personnel will receive a clothing allowance, in addition to the 725.00 referenced in Section (1) above, in the amounts set forth herein.			
	a. Chief of Fire Protection	2,500.00		
	b. Assistant Chief of Fire Protection	1,775.00		
	c. Battalion Chief of Fire Protection	1,700.00		
	d. Captain of Fire Protection	1,650.00		
	e. Lieutenant of Fire Protection (max of 4)	1,550.00		
	f. Mechanic (max of 3)	1,100.00		

3. Retroactivity – The provisions of this ordinance shall be retroactive to January 1, 2023.

4. If any section, sub-section, sentence, clause or phrase of this Ordinance is for any reason held to be unconstitutional or invalid such decision shall not

5. All ordinances or any provisions of any ordinance inconsistent with the provisions of this ordinance except prior appropriations for this purpose herein stated, are hereby repealed as to such inconsistencies and not otherwise.
