ORDINANCE NO. 23-16

**ORDINANCE PROVIDING FOR THE IMPROVEMENT OF LANDS (464 RIDGEWOOD BOULEVARD NORTH) IN AND BY THE TOWNSHIP OF WASHINGTON, IN THE COUNTY OF BERGEN, NEW JERSEY, AND APPROPRIATING \$438,750 THEREFOR CONSTITUTING PROCEEDS OF A GRANT FROM THE COUNTY OF BERGEN.**

**BE IT ORDAINED BY THE TOWNSHIP COUNCIL OF THE TOWNSHIP OF WASHINGTON, IN THE COUNTY OF BERGEN, NEW JERSEY, AS FOLLOWS:**

Section 1. The improvement or purpose described in Section 2 of this ordinance is hereby authorized a general improvement to be made or acquired by The Township of Washington, in the County of Bergen, New Jersey, and there is hereby appropriated therefor the sum of \$438,750 constituting moneys received or expected to be received by the Township from the County of Bergen, New Jersey, 2022 Park Acquisition Grant, as a grant-in-aid of financing said improvement.


Section 2. The improvement hereby authorized and the purpose for the financing of which the appropriation is made as provided in Section 1 of this ordinance is the improvement of lands and any structures thereon in and by the Township located at 464 Ridgewood Boulevard North and shown as Lot 1 in Block 2301 on the Official Tax Map of the Township including recreational and passive use facilities and improvements, together with all structures, landscaping, drainage facilities, equipment, site work, work, materials, engineering, studies, planning and design plans necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Township Clerk and hereby approved.


Section 3. The capital budget or temporary capital budget of the Township is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Township Clerk and are available for public inspection.

Section 4. This ordinance shall take effect after publication after final passage as provided by law.




