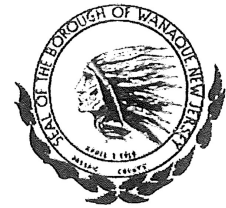

ORDINANCE AMENDING AND SUPPLEMENTING CHAPTER 33 OF THE CODE OF THE BOROUGH OF WANAUKE TITLED POLICE DEPARTMENT

SECTION ONE:

CHAPTER 33-12 APPOINTMENTS. D (New): In accordance with P.L. 2021, C.7 (N.J.S.A. 11A:4-1.3) the Appointing Authority may also appoint a person without having taken a competitive examination if they shall have successfully completed a full Basic Course for Police Officers Training at a school approved and authorized by the New Jersey Police Training Commission within nine (9) months from the date of hire.

CHAPTER 33-27 (NEW) Conflict of Interest and Nepotism Policy.

- A. Definitions: as used herein the following terms shall have the meanings indicated:
1. Family Member or Relative: Spouse, child, parent, sibling, grandparent, grandchild, father-in-law, mother-in-law, brother-in-law, sister-in-law, step-father, step-mother, step-sibling, half-brother, half-sister, nephew, niece, first cousin, aunt, uncle, foster child, or domestic partner.
 2. Elected Official: Person holding the position of Mayor or Council member of the Borough of Wanaque.
 3. Superior Officer: Any police officer of the Borough of Wanaque having supervisory duties and powers over another police officer within the police department.
- B. Hiring and Supervision of Police Officers
1. No person who is a relative or family member of any elected official of the Borough of Wanaque shall be considered for employment as a police officer of the Borough. This shall not restrict nor prohibit the continued employment of an individual as a police officer with the Borough where a family member or relative of an elected official was hired before the effective date of this Ordinance.
 2. No person who is a relative or family member of the Borough Administrator shall be considered for employment as a police officer of the Borough. This shall not restrict nor prohibit the continued employment of an individual as a police officer with the Borough where a family member or relative of the Borough Administrator was hired before the effective date of this Ordinance.
- C. Appointments, Hiring, Promotions, and Discipline
1. The Borough of Wanaque is a Civil Service Jurisdiction for the hiring, firing, promotion, and discipline of Police Officers, governed by the Civil Service Act and Regulations as well as State and Municipal Laws and regulations. This section shall not however prohibit an individual who is a family member or relative and who is otherwise eligible to be appointed, hired, or promoted, from being appointed, hired, or promoted as a police officer, including those appointed pursuant to N.J.S.A. 11A 4-1.3, and this Chapter.
 2. No elected official in the Borough Administrator or superior officer within the Police Department may participate in the promotion process or any other personnel matter of a police officer who is a family member or relative.

- D. Enforceability.
 - 1. The prohibitions herein established are enforceable only to the extent that they are not in violation of applicable Civil Service Statutes or any other applicable state laws.

SECTION TWO: All Ordinances of the Borough of Wanaque which are inconsistent with the provisions of this Ordinance are hereby repealed as to the extent of such inconsistency.

SECTION THREE: If any section, subsection, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid by any Court of competent jurisdiction, such decision shall not affect the remaining portion of this Ordinance.

SECTION FOUR: This Ordinance shall take effect immediately upon final passage, approval, and publication as provided by law.




