**ORDINANCE #6-0-2023**

**ORDINANCE PROVIDING FOR THE IMPROVEMENT OF THE WATER SUPPLY AND DISTRIBUTION  
SYSTEM IN AND BY THE BOROUGH OF WANAQUE, IN THE COUNTY OF PASSAIC, NEW JERSEY, AND  
APPROPRIATING \$881,111.50 THEREFOR CONSTITUTING PROCEEDS OF A GRANT FROM THE  
AMERICAN RESCUE PLAN ACT OF 2021**

**BE IT ORDAINED BY THE BOROUGH COUNCIL OF THE BOROUGH OF WANAQUE, IN THE COUNTY OF PASSAIC,  
NEW JERSEY, AS FOLLOWS:**

**Section 1.** The improvement described in Section 2 of this ordinance is hereby authorized as a general improvement to be made or acquired by The Borough of Wanaque, New Jersey, and there is hereby appropriated therefor the sum of \$881,111.50 constituting moneys received or expected to be received by the Borough from the American Rescue Plan Act of 2021 as a grant-in-aid of financing said improvement.

**Section 2.** The improvement hereby authorized and the purpose for the financing of which the appropriation is made as provided in Section 1 of this ordinance is the improvement of the water supply and distribution system in and by the Borough, including, but not limited to, the installation of new water mains on Jackson Street, Hannibal Place, Arcola Place, Lakeside Avenue, Toquet Street and Haskell Avenue, together with all laterals, services, drainage facilities, landscaping, structures, equipment, site work, work and materials necessary therefor or incidental thereto, all as shown on and in accordance with the plans and specifications therefor on file or to be filed in the office of the Borough Clerk and hereby approved.

**Section 3.** The capital budget or temporary capital budget of the Borough is hereby amended to conform with the provisions of this ordinance to the extent of any inconsistency herewith and the resolutions promulgated by the Local Finance Board showing all detail of the amended capital budget or temporary capital budget and capital program as approved by the Director, Division of Local Government Services, are on file with the Borough Clerk and are available for public inspection.

**Section 4.** The ordinance of the Borough adopted on July 12, 2021 (#14-0-2021) and entitled: "Bond ordinance providing for the improvement of the water supply and distribution system in and by the Borough of Wanaque, in the County of Passaic, New Jersey, appropriating \$1,210,000 therefor and authorizing the issuance of \$1,210,000 bonds or notes of the Borough for financing such appropriation" is hereby repealed. Any moneys expended and obligations incurred pursuant to appropriation made by said ordinance shall be accounted and deemed to have been expended or incurred pursuant to this ordinance
