
1. Chapter 67 A-10(H) (new) All mechanical subcode fees shall follow the plumbing subcode fee schedule listed in Chapter 67A-10(D) of the Borough of Wanaque Code.
2. This Ordinance shall be in full force and effect from and after its adoption and any publication as may be required by law.






ORDINANCE #7-0-2023

BE IT RESOLVED that an Ordinance entitled:


