**BE IT ORDAINED** by the Mayor and Council of the Borough of Wanaque, County of Passaic, State of New Jersey, as follows: SECTION 1. Article IX, Chapter 108-14, Schedule I-No Parking, is hereby amended to include the following described streets:

Name of Street: Union Court; Side: East; Location: From Union Avenue to End

SECTION 2. All ordinances or parts of ordinances not inconsistent herewith shall remain in full force and effect.

SECTION 3. This Ordinance shall take effect 20 days after final passage and publication as required by law.
