AN ORDINANCE AMENDING CHAPTER 114, ARTICLE 8, PARAGRAPH 114-46 TITLED "FIRING RANGES"

BE IT ORDAINED BY THE MAYOR AND COUNCIL OF THE BOROUGH OF WANAQUE, COUNTY OF PASSAIC, AND STATE OF NEW JERSEY AS FOLLOWS:

- Chapter 114, Article VIII Titled Additional Regulations, Paragraph 114-46 is hereby amended as follows:

Paragraph 114-46 Firing Ranges

No person or persons, firm, partnership or corporation shall conduct or permit to be conducted or use any land for the purpose of conducting, any rifle range, pistol range, place for trapshooting, place for skeet shooting or any other use involving the recurrent discharge or firearms at any place within the Borough of Wanaque. With the exception of training, maintenance, and qualifications by the Wanaque Police Department, for Law Enforcement Purposes.

- Ordinances or parts of Ordinances inconsistent with this Ordinance is hereby repealed to the extent of such inconsistency.
- This Ordinance shall take effect upon final adoption and publication in accordance with law.
