AN ORDINANCE AMENDING WANAUKE ORDINANCE CHAPTER 108-14, SCHEDULE I - "NO PARKING"

BE IT ORDAINED by the Mayor and Council of the Borough of Wanaque, County of Passaic, State of New Jersey, as follows:

SECTION 1. Article IX, Chapter 108-14, Schedule I-No Parking, is hereby amended to include the following described streets:

- A. Fourth Avenue 500 feet North from the Boulevard on the East Side; and
- B. The Boulevard South 100 feet from the Fourth Avenue intersection on the East Side.

SECTION 2. All ordinances or parts of ordinances not inconsistent herewith shall remain in full force and effect.

SECTION 3. This Ordinance shall take effect 20 days after final passage and publication as required by law.
