**AN ORDINANCE TO AMEND AND SUPPLEMENT AN ORDINANCE  
FIXING THE SALARY, WAGES AND COMPENSATION OF CERTAIN  
OFFICERS, EMPLOYEES AND SERVANTS OF THE BOROUGH OF  
WALLINGTON, COUNTY OF BERGEN AND STATE OF NEW JERSEY**

**BE IT ORDAINED** by the Governing Body of the Borough of Wallington, County of Bergen and State of New Jersey, as follows:

SECTION 1. AN ORDINANCE TO FIX THE SALARY, WAGES AND COMPENSATION OF CERTAIN OFFICERS, EMPLOYEES AND SERVANTS OF THE BOROUGH OF WALLINGTON is hereby amended and supplemented as follows:

SECTION 3. The Salaries, wages and compensation as set forth herein above shall be retroactive as of January 1, 2021, except if expressly indicated to the contrary.

SECTION 4. No employee hired after the adoption of this Ordinance shall be entitled to any increase in salary until after the end of the calendar year in which the employee was hired, and the completion of the employee’s 90-day probation period.

SECTION 5. All salaries and allowances and other provisions of the Ordinance to which this Ordinance is an amendment and supplement, which have not been expressly amended or supplemented herein, are herein incorporated as though set forth at length and shall be and remain in full force and effect.

SECTION 6. If any section, part of any section, clause or phrase of this Ordinance is for any reason held to be invalid, the remaining portions of this Ordinance shall continue to be valid and in full force and effect. The Governing Body of the Borough of Wallington declares that it would have passed this Ordinance and each section and subsection thereof, regardless of the fact that one or more sections or portions of sections hereof may be invalid.

SECTION 7. This Ordinance shall take effect immediately upon passage and publication according to law.

SECTION 8. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed as to such inconsistencies.
