West Lebanon Township Ordinance No. 536

AN ORDINANCE ADOPTED BY THE BOARD OF COMMISSIONERS OF THE TOWNSHIP OF WEST LEBANON AMENDING THE ORDINANCE ADOPTED ON THE 6TH DAY OF JUNE 2023 BY AMENDING SUBSECTION F, BY DELETING SUBSECTION F RELATED TO PENALTIES AND BY REPLACING THAT SECTION WITH A NEW SUBSECTION F.

WHEREAS, West Lebanon Township adopted an Ordinance on or about June 6, 2023, known as Ordinance No. 535 ("Ordinance"), regulating parking of commercial vehicles on Township streets and imposing penalties for the violation of that Ordinance.

WHEREAS, the Board of Commissioners now desires to amend the Ordinance at Section F to delete the provisions thereof regarding penalties and replace the penalties contained in Section F with the penalties contained in this Ordinance.

AND NOW, on the ______ day of ______, 2023, be and it hereby is ORDAINED and ENACTED by the West Lebanon Township Board of Commissioners:

1. The Ordinance regulating parking within the Township is hereby amended at Section F to delete the penalties contained in Section F and to replace that language at Section F with new penalties as stated in this Ordinance.

2. Section F of the Ordinance shall henceforth state as follows:

F. PENALTIES. (a) Any person, firm, company, business, or corporation, who shall violate any provision of Ordinance No. 535 as adopted and codified, shall receive and pay a penalty of \$50.00 as authorized by the Pa. Motor Vehicle Code for parking offenses.

(b) In default of that penalty defined in (a) or in the case of a repeat offender, the Township may impose a criminal fine issued upon the violator of the Ordinance, in the minimum amount of \$100.00 and in the maximum amount of \$1,000.00, plus any costs, court fees, attorney's fees, and in default of the payment of any such fines, costs, court fees, and attorney's fees, the violator may be sentenced to a term of imprisonment not to exceed 30 days. Upon the failure of any violator to pay the fine so imposed, this fine may be enforced by summary action before the Magisterial District Judge. Each day that a violation of the Ordinance continues shall constitute a separate violation punishable as a separate offense under this provision.

3. In the event any provision, section, sentence, clause, or part of this Ordinance shall be held to be invalid, such invalidity shall not affect or impair any remaining provision, section, sentence, clause or part of this Ordinance, it being the intent of this Township that such remainder shall be and shall remain in full force and effect.

4. Except as explicitly repealed hereby, all parts of Ordinances No. 535 that are not inconsistent herewith shall be and the same expressly remain in full force and effect.

5. This Ordinance shall be effective in accordance with law.
