## AN ORDINANCE AMENDING CHAPTER 315, ARTICLE II, SECTIONS 7A OF THE REVISED GENERAL ORDINANCES OF THE BOROUGH OF WHARTON, COUNTY OF MORRIS, STATE OF NEW JERSEY

BE IT ORDAINED by the Governing Body of the Borough of Wharton that Chapter 315 Vehicles and Traffic, Article II Parking, Section 7A- Parking, stopping or standing prohibited at all times on certain streets of the revised general ordinances of the Borough of Wharton are hereby amended as follows:

Chapter 315. Vehicles and Traffic
§ 315-7. Parking, stopping or standing prohibited at all times on certain streets.
A. No person shall park a vehicle at any time upon any of the streets or parts thereof described below:
